production-search	This Uni-versal Extras cookie is used to improve usability of our Production Search feature.
appInvitationFormSubmitted	This Uni-versal Extras cookie is part of our App Invitation feature.
CookieConsent cc_cookie_accept cc_cookie_decline	Stores the user's cookie consent state for the current domain.
AF_BANNERS_SESSION_ID	This AppsFlyer cookie collects data on the user, used to make advertisement more relevant.
lastExternalReferrer lastExternalReferrerTime	This Facebook cookie detects how the user reached the website by registering their last URL-address.
rc::a rc::c	These Google reCAPTCHA cookies are used to distinguish between humans and bots. This is beneficial for the website, in order to make valid reports on the use of their website.

Registers data on visitors from multiple visits and on ANONCHK

multiple websites. This information is used to measure the

efficiency of advertisement on websites.

MC1 Used by Microsoft to keep statistics on what pages the user MS0

has visited and how often an ad click leads to a purchase or

other actions on the advertiser's website.
